# What Youth Want

Alberta Conference President, Frank Tochterman, interviews Alberta Conference Youth Director, Richard Williams

**President:** I understand you have been researching the needs of the youth and young adults in the Alberta

Conference. How have you been doing this?

**Richard:** Well, besides meeting young people in their churches and at conference events, we had a Visioning Weekend in November of 2002.


**President:** Tell me a bit about the Visioning weekend.

Richard: Each church in the Conference was invited to send a delegate. The delegates were to be youth or youth leaders. We had 23 delegates at Foothills Camp for the weekend. We went through a process in which we talked about what is currently happening in youth ministry, what the ideal youth / young adult programming would entail, and what might be some tangible goals for ourConference in the future.

**President:** What are some of these tangible items that the delegates wanted?

**Richard:** The youth suggested five areas of focus:

- Youth want to be more involved in their local churches in meaningful ways. They want to be taught how to be elders, deacons, Sabbath School leaders, etc. They want to sit on church boards and planning committees. They even suggested that a young person be on the Conference Executive Committee.
- 2) Youth want to be taught how to do evangelism and be given opportunities to reach out to their communities. They asked for an event that could bring together youth from various areas to be trained and do creative evangelism, including street ministry, door-to-door outreach, etc.
- 3) Youth would like more events like mission trips, spiritual retreats, and leadership / evangelism training.
- 4) Youth discussed setting up regional councils that would plan events for the youth in their areas. The councils would promote networking and fellowship between area youth. The councils would also be a conduit for needs and information to be shared with the Conference Youth Director.



were suggested.

**President:** What is happening with these initiatives and what are some of the upcoming events for youth and young adults in the conference?

**Richard:** A steering committee has been formed to address the creation of youth councils. We are working on the structure and purpose of these groups. I hope they will be up and running within the next couple of months.

Plans are being made to have a youth and a young adult spiritual retreat this fall. These events are most likely to be at Foothills Camp in October. A mission trip to Bangkok, Thailand, is being planned for December. It is a collective effort of all the conferences across Canada. The participants will spend one week doing community service and outreach and then have the opportunity to attend the General Conference Youth Congress. This will be a once-in-alifetime opportunity for our youth!

Finally, we are hoping to launch a youth newsletter and website later this year. These will be exciting new ways to get information out to our young people. We are currently looking for youth with ideas, writing ability, and website building experience to help in making these initiatives a reality.







# You were asking about . . .

#### NEW CANADIAN ANTI-TERRORISM CHARITABLE RECEIPT REQUIREMENTS

During 2002, a new Act of the Federal Parliament, known as the Canada Customs & Revenue Agency Anti-Terrorism Act (December 18, 2001), came to the forefront in the operations of all Canadian charities. The Alberta Conference shared this information at various times in meetings of teachers, pastors, elders, treasurers and Regional Management Teams. However, it seems advisable to distribute this information to every church member within the Alberta Conference.

All Charitable Receipts are issued under the provisions of various Acts of the Government of Canada. The implementation of these Acts is carried out by the Canadian Government Department known as the Canada Customs and Revenue Agency (CCRA), through its Charities Division. Every Charitable Receipt is therefore subject to the interpretation of the Government and not to the interpretation placed on donations by any charitable organization, such as a conference, church or school, or by any individual, such as a treasurer, pastor, principal, etc.

It is important that charitable donors understand the Government's hinking about the issuance of Charitable Receipts: Essentially, the Government believes that since it allows a Deduction from Income Tax for the Charitable Donation, that therefore the Government "owns" the donated money and has control over the use of the donated money. This philosophy is reflected in relatively new legislation, as well as throughout earlier regulations.

#### Canada Customs & Revenue Agency Anti-Terrorism Act (December 18, 2001)

The Seventh-day Adventist Church in Canada (SDACC), as well as the Canadian Council of Christian Churches (CCCC), both recently stressed some very significant implications for Charities in recent Canadian Anti-Terrorism legislation.

The Anti-Terrorism Act of December 18, 2001 came about as a result of the 9-11 terrorist attacks on the World Trade Centre in New York City. This Act is based on the concept that Canada's National Security outweighs normal Civil Rights and the Act overrides the usual burden of proof for Canadian legal proceedings.

The reality for Charities is that if the Government through its audits or other means discovers that a conference, church or school has issued a Charitable Receipt that does not comply with the Act, the Government can immediately cancel the Charitable Registration of the non-complying local conference, church or school. At the same time the Government can cancel the Charitable Registration of the entire Seventh-day Adventist Church in Canada, based on the non-complying actions of one or more local entities.

Under Anti-Terrorism legislation, the Government can cancel the Charitable Registration of entire charitable organizations without the usual hearing process, and there is no guarantee that charitable organizations will be allowed to be present when their appeal for re-instatement comes before the Government, following cancellation. It is therefore critical that each charitable gift in Canada complies with the Anti-Terrorism rules described here.

First is a list of charitable GIFTS THAT HAVE NOT CHANGED due to new legislation.

# Charitable Receipts That HAVE NOT CHANGED Due to Anti-Terrorism Legislation:

- There is NO CHANGE in Charitable Receipts for Regular Tithes and Offerings There is no change in Charitable Receipts for donations to all regular tithes, offerings and other donations that are collected at the conference and local church – for example, Tithe, Mission Offerings, Alberta Advance, ADRA offerings, Sabbath School Expense, 13<sup>th</sup> Sabbath, Annual Sacrifice, Birthday/Thank Offerings, Sabbath School Investment, Church Family Budget, Worthy Student, etc.
- There is no change in Charitable Receipts for donations to local church projects that are voted by the Church Board to operate in Canada as part of local church ministries – for example, donations for Community Service projects, Food Banks, Soup Kitchens, Evangelism, Native Ministries, Evangelistic programs, the Poor Fund, church or school building or renovation projects, etc.
- There is no change in Charitable Receipts for donations to other Registered Charities within Canada, although it is preferable if the other Registered Charity writes the receipt, if possible. Charitable Receipts may be written for donations to any other Registered Canadian Charity, such as "It Is Written." Please use the CCRA website to know if another charity is registered in Canada before issuing a charitable receipt and before passing the money on to the second Registered Charity, known by CCRA as a "Qualified Donee."
- There is no change in Charitable Receipts for donations to "soft costs" for mission projects outside of Canada and approved by the Conference, Church or School Board operating as a Registered Canadian Charity – for consumable items that will not be left in a country outside of Canada, such as donations for travel to the territory and the cost of staying and eating there.

Now we turn to Charitable Receipts that MUST NOT be issued by the local conference, church or school for reasons of Anti-Terrorism Legislation or other CCRA legislation:

# Charitable Giving Receipts that MUST NOT Be Written Locally

- Charitable Receipts must not be written by the conference, local church or school for ministries or projects within Canada that have not been voted by a Board as part of the entity's local ministry or mission.
- Charitable Receipts must not be written for donations to other Canadian projects or ministries unless it is confirmed that the other ministry definitely has a Canadian Registered Charity number. Even then it is preferable for the donor to send the donation directly to the other Canadian

Registered Charity. However, if the gift is receipted by a registered local church or a registered local school, record must be kept of the other Registered Charity's number for reporting the transfer of the donation from the first Registered Charity to the second Registered Charity.

• Charitable Receipts must not be written by the conference, local church or school for donations to be sent to the United States or to anywhere else in the world for any "hard" costs, such as sending or taking money to any other country for any purpose whatsoever; sending or taking building materials, equipment, materials or supplies of any type that will be left in any country outside Canada; or for any donation whatsoever that will not be consumed quickly on arrival in the other country.

IF THE RECEIPT CAN'T BE WRITTEN LOCALLY, HOW CAN DONATIONS BE SENT TO SPECIFIC MISSION PROJECTS OUTSIDE OF CANADA AND RECEIVE A CHARITABLE RECEIPT?

At this time there are only two ways to send donations for projects outside of Canada and receive a Charitable Receipt: The first is through the Seventh-day Adventist Church in Canada Joint Ministries Agreement and the second is through ADRA Canada. Both methods are explained here.

#### 1. The SDACC Joint Ministries Agreement

The Seventh-day Adventist Church in Canada has entered into a Joint Ministries Agreement with the Federal Government to monitor all gifts from SDA Church Members to all countries outside of Canada. This means that all donors to projects outside of Canada, whether donating money or materials of any kind will be left in the other country, and where a charitable receipt is desired, must apply to the Joint Ministries Agreement Committee at the SDACC, before making the donation, to find out if the gift will qualify for a charitable receipt.

Here is how to apply for a Joint Ministries Agreement Charitable Receipt:

- a. Contact the SDACC Treasurer, Gerald Northam, at 1–905–433–0011, Ext. 207, e-mail him at gnortham@sdacc.org or write him at Gerald Northam, Treasurer, Seventh-day Adventist Church in Canada, 1148 King Street East, Oshawa, ON L1H 1H8. This is the only person to contact with respect to a charitable receipt for donating to a project outside of Canada. This procedure may be broadened in the future, but this is currently the only way.
- b. Individual donors to a non-Canadian project, or leaders of a non-Canadian project, should contact Mr. Northam before sending a donation to him or before announcing a fund raising campaign, to be sure that project donations are eligible for a charitable receipt.
- c. When you receive approval for a SDACC Joint Ministries Agreement Charitable Receipt, send the donation to Gerald Northam at the address in a. above. The receipt will be issued by the SDACC.

- d. For the present time, all inquiries regarding gifts for outside of Canada must be directed to the SDACC Treasurer. Local conferences are not involved at this time.
- e. If a donation is not eligible for a Joint Ministries Agreement Charitable Receipt, it may still be given personally by the donor to the project, but it cannot receive a charitable receipt at any level of church or school organization.
- 2. ADRA Canada—With Respect to Charitable Receipts for Local Church Mission Projects Outside of Canada (This does not change regular donations to ADRA and it does not change donations to ADRA Annual Appeal.)

The main reason that local conferences, churches, and schools cannot issue charitable receipts for money or materials to be left in another country, is because the local entity does not usually have the resources to follow the gift for the lifetime of the gift, to ensure that the gift is used for its intended purpose and that it does not at any time fall into the hands of terrorists. Following the gift is a main requirement of new Canadian Anti-Terrorism legislation.

ADRA already has a network of ADRA employees around the world, and since ADRA has been working in partnership with the Federal Government for many years, and always follows the use of both its donations and Federal Grants, ADRA is in a unique position to be able to continue to issue Charitable Receipts for donations to projects outside of Canada.

ADRA has specific projects of its own and it may not be able to assist with new projects sponsored by individuals or churches or schools. For this reason, anyone wishing to have ADRA issue a charitable receipt must contact ADRA before a project is begun. If ADRA cannot take on a new project, individuals or groups may wish to assist with sponsoring or participating in a current ADRA project and receive a charitable receipt in that manner. All ADRA charitable receipts for specific projects are issued at the discretion of ADRA and ADRA must be contacted if a project charitable receipt is desired from ADRA.
