



CHARITIES AND GIVING GLOSSARY:

- **Arm's length** describes a relationship where persons act independently of each other or who are not related.
- **Bequest** a property a qualified donee receives from the will of a deceased person.
- Cash gifts generally include cheques, money orders, bank drafts, as well
 as cash. Donations made by debit card and by credit card are also considered
 cash gifts.
- **Designated gift** a type of gift made between registered charities that are not at arm's length to each other. A gift becomes a designated gift if the donor charity identifies it as a designated.
- Qualified donee an organization that can issue official donation receipts for gifts it receives from individuals and corporations. It can also receive gifts from registered charities.
- Registered an organization has applied to the CRA and received approval
 as meeting the requirements for registration as a charity and has been issued
 a charitable registration number.
- **Restricted funds** are funds tied to a specific use and not available for the general purposes of the organization.

POLICY RECOMMENDATIONS:

- **DESIGNATED GIVING POLICY.** This is a policy regarding restricted funds or donations given for a specific project or Church ministry. Once such a policy is adopted and members are made aware, the Board may legally vote to redesignate restricted funds should a project be over-funded or terminated. Without such a policy, neither the Board nor the church in a business meeting may legally vote to redesignate restricted funds to a purpose different from what they were donated for. This policy must be published in the bulletin or posted on the bulletin board so that donors are aware of it.
- **BENEVOLENCE FUND POLICY.** This is a policy where a committee, chosen by the church board members, will study the case of each individual or family requesting financial assistance from the church. After reviewing the case, it is expected that the benevolence committee will be able to recommend to the church board a fair financial assistance that the person/family in need could be assisted. The process must be clear and well-known by the church members. Please note that the financial aid applies to anyone in need, a church member, or a friend from the community, and it would be subject to church financial availability. A sample policy template is available at the treasury office as a guide.

Discuss these with the church board and have the board adopt the two policies mentioned above. Take note of the Action Number and date. As this is the standard practice in the charitable industry, we recommend that the churches have these policies adopted.
